**MATCH DATES:** June 25<sup>th</sup> and 26<sup>th</sup>  
**RULES:** Current NRA rules will govern the conduct of the match.  
**RIFLES ALLOWED:** Service Rifle, Rule 3.1; Any Rifle, Rule 3.2; NRA Match Rifle, Rule 3.3; Palma Rifle- Rule 3.3.3; NRA Any Sight Match Rifle, Rule 3.3.4; F-Class- Rule 3.4 (a) & (b)  
**TARGETS:** Conventional LR; F-Class LRFC.  
**CLASSIFICATION:** NRA High Power classification cards, or temporary score books.  
**CATEGORIES:** Match Rifle, Service Rifle, Palma, F-Open and F-TR. Minimum of 5 shooters required to form a class/category. Classes and/or categories will be combined at the discretion of the match director if there are insufficient shooters.  
**SQUADDING:** At Statistical Office commencing at 0700. Prepaid entries will be squadded first. Entries made by telephone cannot be guaranteed.  
**ENTRY FEE:** \$80.00 Saturday and Sunday. Fee includes target puller.  
**ENTRIES LIMITED:** FIRST 75 PAID COMPETITORS.  
**DEPOSIT:** \$10.00 deposit received prior to the match will hold entry.  
**AWARDS:** Awards will be given in each category and class for each stage or match on each day. Awards will be given to each multiple of 3 competitors in each category. Competitors may not win more than one award in each match.  
**CHALLENGES:** \$2.00

**SATURDAY:** ANY RIFLE IRON SIGHTS, SERVICE RIFLE, PALMA, F-OPEN and F-TR  
**MATCH #1:** 1000 yard slow fire. unlimited sighters, 20 rounds for record prone. Time limit 30 minutes.  
**MATCH #2:** 1000 yard slow fire. unlimited sighters, 20 rounds for record prone. Time limit 30 minutes.  
**MATCH #3:** 1000 yard slow fire. unlimited sighters, 20 rounds for record prone. Time limit 30 minutes.  
**MATCH #4:** Aggregate of Matches 1 – 3.

**SUNDAY:** ANY RIFLE ANY SIGHTS, SERVICE RIFLE, PALMA, F-OPEN and F-TR  
**MATCH #5:** 1000 yard slow fire. unlimited sighters, 20 rounds for record prone. Time limit 30 minutes.  
**MATCH #6:** 1000 yard slow fire. unlimited sighters, 20 rounds for record prone. Time limit 30 minutes.

**MATCH #7:** Aggregate of Matches 5 & 6.  
**MATCH #8:** Aggregate of Matches 4 & 7.

**Match #2:** 4-man Team, 1000 yard prone slow fire. 2 sighters per firing member. (63 minutes/2 shooters)  
**Match #3:** Aggregate of matches 1 & 2.

**Practice:** Individuals will be able to participate along with the teams.

**CLASSIFICATION:** NRA classification cards, or temporary score books are required.

**CATEGORIES:** Minimum of 5 shooters required to form a class/category. Classes and/or categories will be combined at the discretion of the match director if there are insufficient shooters.
